Release of Liability:

This agreement is between (student's name) _____; Austin Martial Arts Academy; Empty Hands Incorporated; Kid Safe; Realistic Assault Defense; all special event programs; camp programs; its volunteers; its instructors; all other employees, affiliated members and any events held at offsite locations; hereinafter collectively referred to as Austin Martial Arts Academy or as AMAA.

In consideration for enrollment in the AMAA programs, I make the following statements and promises:

1) I acknowledge before signing this agreement, that many of the techniques taught in AMAA programs are intended strictly for self-defense and physical fitness purposes, and that these techniques are not to be used in an aggressive manner against any person or property. I understand that I may be expelled at any time from participation in a program or event if the instructors learn that I used these techniques in an aggressive manner against anyone or anything.

2) I agree that this agreement shall be binding upon my heirs, next of kin, representatives, and assigns and that they: (a) will not make a claim against the AMAA for any injury, death, or property damage resulting directly or indirectly from my participation in an AMAA program or event; and (b) will release and discharge the AMAA from any claims or demands arising from injury, death, or property damage to me caused by my participation in an AMAA program or event.

3) I am aware that participation in AMAA programs can involve strenuous physical activity and I understand that my training as a student could involve physical contact between myself and other students, instructors and training equipment, including, but not limited to, punching, blocking, kicking, throwing, rolling and grappling. I understand that I may be participating in simulated self-protection scenarios that may be physically and/or emotionally stressful. With this knowledge, I voluntarily assume the full risk and responsibility for any and all bodily injury, death, or property damage arising from the actions or conduct of the AMAA, its instructors, or other students; from my actions or conduct while on AMAA premises or during an AMAA-sponsored event; or from my actions or conduct as an AMAA student.

4) I promise to defend, indemnify, and hold harmless the AMAA from any claims made by third parties alleging injury or damage resulting from my conduct and activities while on AMAA premises or during an AMAA sponsored event, from my conduct as an AMAA student, and from my use of any techniques learned in an AMAA program.

5) I agree to allow AMAA to use my still or moving picture for any promotion and/or publicity relating to AMAA. I understand that I will not receive any compensation for such use.

6) I have not requested nor received any warranties as to the effectiveness of any AMAA program.

7) If I am under 18 years of age, I have advised an AMAA instructor of this fact, and I have shown this agreement to my mother, father, or legal guardian. My mother, father, or legal guardian hereby consent to my participation in AMAA programs/events and further agree to be bound in full by the terms and provisions of this agreement as evidenced by their signature below.

8) I agree that there have been no oral representations, statements, or inducements made apart from this written agreement.

9) I understand that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state of Texas and that if any portion thereof is held invalid, I agree that the balance shall, notwithstanding, continue in full force and legal effect.

10) In the event of an injury, condition, or death that surpasses the capabilities of our First Aid/ CPR trained Instructor's. I hereby give permission to obtain qualified emergency medical assistance to my son/daughter and do not hold Austin Marital Arts Academy, The Children's Center of Austin or any Independent Contractors liable for such occurrence.

11) I have carefully read this agreement and fully understand its contents. I am aware that this agreement is a release of liability and responsibility between myself and The Austin Martial Arts Academy; Empty Hands Incorporated; Kid Safe; Realistic Assault Defense; all special event programs; camp programs; its volunteers; its instructors; and all other employees and affiliated members. AMAA POLICIES AND PROCEDURES

(Please Read & Keep a Copy of this Information)

Cancellations and Refunds:

Refunds will be given when notification of cancellations have been received within 24 hours from date of purchase. Notification of cancellations later than that will be issued a credit provided it is within seven days prior to camp start date. Credits may be applied to other camp dates or Austin Martial Arts Academy Programs. A \$20 administrative fee will apply for all cancellations. There is no prorating of fees for missed classes or for late enrollments. Failure to attend does not constitute a refund or cancellation and returned transactions are subject to a \$25.00 returned transaction fee.

When to Arrive:

Please arrive promptly at 9:00am so camp can begin on time.

Pick Up/Drop Off:

For your child's safety, you will be required to escort your child into the building and sign in and out each day. Your child will be released only to those authorized by you below. Photo identification may be required. Camp will meet promptly @ 9am. Rooms are not available for camp until 9 am, so please NO EARLY DROP-OFFS. ;-) Camp pick up is @ Noon. (Late Pick up is \$1 per minute.)

What to Wear:

Campers should be comfortably attired with clothes that will allow them to move freely and fully engage in all activities; loose comfortable play clothes for indoor/outdoor use are best. Wear tennis shoes for outside playtime. Bring a light wind/rain jacket. Always wear and bring sunscreen. On swim days have a towel and bathing suit. Each camper will receive a Karate T-shirt.

What to Bring:

As each child's eating habits vary, please send enough hearty & healthy snacks & juice boxes or water for the appropriate amount of time, for your child's appetite Please send your child with a "full breakfast belly" to have the most energy for their karate day. It's best to send a labeled bottle of water and/or a juice box and several healthy snacks. We will take snack breaks as needed.

Minimum Class Enrollment:

In the event that a minimum number of students have enrolled, sessions may be cancelled, combined or postponed.

Substitution:

AMAA reserves the right to substitute or replace teachers.

Medications:

I understand that if my child needs to take any prescription medication, a parent/guardian must personally administer such medication.
